- II. Discussion to hire a secretary to work with the Assistant and how to use the \$13,000 available for new jobs.
 - A. John Nicholas motioned to have applications made out and distributed to the Pleasant Point and Peter Dana Point Reservations by Wednesday, October 6, 1971, for the position of Assistant to the Economic Developer with a salary of \$8500 a year and for the position of secretary to the Assistant with a salary of \$4500 a year. These applicants are to be hired by Joint Council. Edward Socobasin seconded the motion and was voted all in favor.
- III. The date for the applications to be in is October 18 for the Joint Council meeting scheduled for Monday, October 18, 1971 at Peter Dana Point at 7:30.
- IV. Eugene Francis adjourned the meeting.

Purpose-General discussion, resolution concerning Community Building, and Francis Sapiel had certain things to bring up.

Order of Business

- Gene read a letter from D. J. Bushey, Field Representative, EMDD concerning a representative to serve on the Board of the OEDP Committee. Any Passamaquoddy interested in serving on the Board may contact Gene. grooted alogast dad bebien
 - Gene read a letter from M. Ring concerning reintroduction of the Scholarship bill to the Special Session. It is the same bill as submitted last time, except that it is for one year instead of two. 19-21. Generally attend the Fourte County

Frank Tomah motioned to submit the bill to the Special Session providing for scholarships for North American Indians residing in Maine. The motion was seconded by John Nicholas and they vote all in favor.

- III. Gene announced that he sent in a letter to Father Rokos on Indian Services for various funding on reservations.
- Discussion of land lease and location for Coummunity Building. The Housing Authority needs approval from the Council to lease land for 20 years for the Community Building so their proposal can be sent in. The location is not needed yet and the Council can retain authority for the site.

Arthur Newell motioned to accept the resolution to lease land to the H.A. for the Community Building, as read, with approval of the site later. The motion was seconded by John Nicholas and voted all in favor.

V. Francis Sapiel brings up certain things-

1. Winterizing houses

2. Repair distribution and control

Francis Sapiel motioned that anyone with a felony charge should not hold office in the community. Arthur seconded the motion and was voted all in favor. It shall be submitted to the next legislature.

- II. Gene read a letter from the Native American Rights Fund on the land case--will have a report in December.
- VIII. Read results of School Board and Council elections.
- OX. Job available at Alcholism Counseling Center for one person to work at four places—the three reservations, and Houlton—— Gene recommended Dan Francis to Counseling Center in Bangor.

News from the Governor

Oct. 19-21, Gene will attend the Fourth Annual EDA Planners Seminar for Economic Development Specialists and Planners on Indian Reservations in Phoenix, Arizona. Moses Neptune will also be attending. The program includes special speakers, visits to Indian Reservations, presentation of various projects, and special events including Indian dancers. Gene will also be on a question-answer panal.

On Oct. 13, Governor Gene went to Augusta for a meeting concerning EEA and tribal business. Three new jobs will be availabe to our reservation from EEA. The jobs are: sanitary engineer, health service coord., and fireman.

The Housing Authority is making final payment to close out projects, EDA and WQA, for the Water & Sewage Plant.

The houses that were planned for last August were delayed because HUD initially provided for \$15,000 homes. However, the new houses that will be built will be valued at \$20,000. Six trailers are definitely going to be brought in by H.A. as temporary homes for those who most need them until the houses are complete.
